No set-up until your vehicle is fully unloaded and moved to the designated parking area. Vendors may not keep their car parked in the fire lane behind the fieldhouse. Show opens to the public at 9am. Early bird shoppers tend to arrive early, however, selling is not allowed until 9am. No soliciting to other vendors, approaching patrons, or distribution of advertising for anything other than what you are selling. All items and displays must stay within designated space as marked with chalk. Space must be kept clean throughout the event and be left spotless afterwards. If trash is left behind, vendor will be banned from participating in shows for one year. **Prohibited Items**: Fireworks, silly string, guns, knives, and other items considered weapons, automobiles, aircraft, boats, adult-themed/pornographic items, alcohol, drugs and drug paraphernalia, tobacco and tobacco paraphernalia. **Stealing: I acknowledge that I will not steal from other vendors. If this occurs at any event the participant will be**

banned for one calendar year from when that occurred

Food: No vendor may sell food without permission from the Garage Sale Director. Food must not conflict with concession stand sales and requires proof of a health permit and general liability insurance.

Agreement: I am applying to participate as a vendor and understand / agree to follow the rules stated above. If I do not adhere or if I misrepresent myself or my items I am selling I will be asked to leave without refund.
